

NOTICE OF MAKING AN ORDER

HIGHWAYS ACT 1980 WILDLIFE AND COUNTRYSIDE ACT 1981

HAMPSHIRE COUNTY COUNCIL

THE HAMPSHIRE (EAST HAMPSHIRE DISTRICT NO.37) (PARISH OF BINSTED - PART OF FOOTPATH NO.37) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2026

The above-named Order, made on 27 May 2026 under Section 119 of the Highways Act 1980, will divert part of the above-mentioned public footpath from its current alignment which commences at a point approximately 15 metres from the access road to River Hill Farm and proceeds in a north-easterly direction between a building and a storage yard to SU 7886 4118. The proposed diversion route will commence at the previously described junction with the access road to River Hill Farm, proceeding in a north-westerly direction to SU 7884 4112, continuing north-eastwards along the edge of a paddock to SU 7886 4118.

A copy of the Order and the Order map have been placed and may be seen free of charge at the offices of Hampshire County Council, The Castle, Winchester, SO23 8UJ and at the offices of East Hampshire District Council, Monterey House, Bedford Rd, Petersfield GU32 3LJ; or online at www.hants.gov.uk/publicnotices. Copies of the Order and the map can be provided on request.

Any representations about or objections to the Order may be sent in writing to the Head of Countryside Access, Hampshire County Council, The Castle, Winchester, SO23 8UJ or via e-mail to row.notices@hants.gov.uk quoting reference:- PPO 5238 no later than 31 July 2026. Please state the grounds on which they are made.

The personal data you provide in any representation will be treated in accordance with Data Protection Legislation, and may be published in a decision report, be disclosed to other interested parties, including the landowner (or their representatives). It may also be made public if the matter is referred to the Planning Inspectorate. Your data will be retained for a maximum period of 3 years from the date that the application is resolved. The legal basis for our use of this information is the compliance with a legal obligation – Highways Act 1980.

THE HAMPSHIRE (EAST HAMPSHIRE DISTRICT NO.37) (PARISH OF BINSTED - PART OF FOOTPATH NO.37) PUBLIC PATH DIVERSION AND DEFINITIVE MAP AND STATEMENT MODIFICATION ORDER 2026

This Order is made by Hampshire County Council ("the authority") under Section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the owner of the land crossed by the footpath described in paragraph 1 of this order it is expedient that the line of the path should be diverted.

This Order is also made under section 53A(2) of the Wildlife and Countryside Act 1981 ("the 1981 Act") because it appears to the authority that the Hampshire Definitive Map and Statement of Public Rights of Way (dated 15th December 2007) require modification in consequence of the occurrence of an event specified in section 53(3)(a)(i) of the 1981 Act, namely, the diversion (as authorised by this order) of a highway shown or required to be shown in the map and statement.

Mr Masnaghetti has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order and any expenses which are incurred in bringing the new path into a fit condition for use by the public.

East Hants District Council has been consulted as required by Section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way over the land situated at Binsted shown by a bold continuous line on the map contained in this Order and described in Part 1 of the Schedule to this Order shall be stopped up when Hampshire County Council has certified that the work necessary to bring the site of the new footpath specified in paragraph 3 below, into a fit condition for use by the public has been carried out, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by deleting from it that public right of way.
2. Notwithstanding this Order all Statutory Undertakers shall have the same rights over the land referred to in paragraph 1 as they have hitherto enjoyed.
3. There shall be from the date of confirmation of this Order a public footpath over the land situate at Binsted described in Part 2 of the Schedule and shown by a bold broken line on the map contained in

this Order, and thereupon the Hampshire Definitive Map of Public Rights of Way (dated 15th December 2007) shall be modified by adding that footpath to it.

3A. The Hampshire Definitive Statement of Public Rights of Way (dated 15th December 2007) shall be modified as described in Part 4 of the Schedule to this Order.

PART 1

DESCRIPTION OF SITE OF EXISTING RIGHTS OF WAY

Binsted Footpath No. 37 (A-C) SU 7884 4111 to SU 7886 4118

That part of Footpath No.37 in the Parish of Binsted which commences at SU 7884 4111 (Point A on the plan) and proceeds generally north-eastwards to SU 7886 4118 (Point C).

Approximately 67 metres in length.

PART 2

DESCRIPTION OF SITE OF NEW RIGHT OF WAY

Binsted Footpath No. 37 (A-C via B) SU 7884 4111 to SU 7886 4118 via SU 7884 4112

A 2.5-metre-wide grass path in the Parish of Binsted, commencing at SU 7884 4111 (Point A) proceeding north-westwards to SU 7884 4112 (Point B), continuing north-eastwards along the edge of a paddock to SU 7886 4118 (Point C).

Approximately 74 metres in length.

"The path follows a diverted route, 2.5 metres wide, between 7884 4111 and 7886 4118"

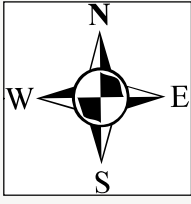

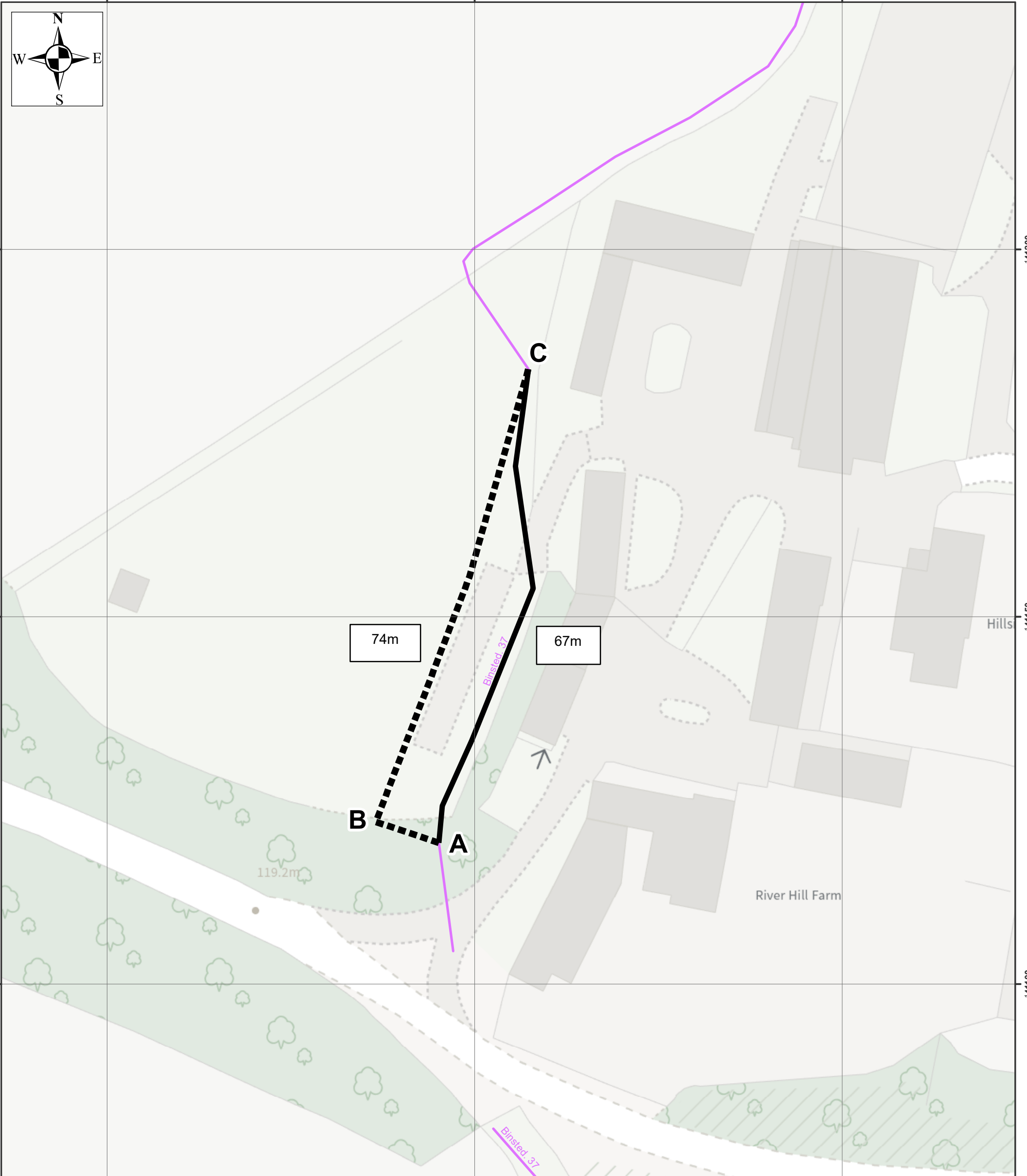
