

**THE HAMPSHIRE (BASINGSTOKE AND DEANE) (PROHIBITION AND
RESTRICTION OF WAITING AND LOADING AND PARKING PLACES)
(CONSOLIDATION) ORDER 2021 (VARIATION NO. 23) (THE GREEN) ORDER 2025**

NOTICE IS HEREBY GIVEN that Hampshire County Council made the above-mentioned Order on 2025, in exercise of its powers and duties under Sections 1, 2, 3, 4, 32, 35, 45, 46, 47, 49, 51, 53 and 122 of the Road Traffic Regulation Act 1984 (“the Act”), Part IV of Schedule 9 to the Act, and of all other enabling powers, after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, and having discharged its duty under section 122 of the Act.

GENERAL NATURE AND EFFECTS OF THE ORDER: Will be to introduce a No Waiting at any Time restriction on The Green in Tadley as outlined in the below schedule:

No Waiting at any Time

Road Name	Side	Description
The Green	South	Between a point 16 metres west of its northern junction with A340 Tadley Hill and point 61 metres west thereof.

DATE OF OPERATION: The order will come into force on 2025.

Statement of reasons

An extension to the existing double yellow lines on the southern side of The Green, Tadley, is being proposed to allow a greater length of carriageway for vehicles to queue. At present, through vehicles are held up by parked vehicles, causing congestion that backs onto the A340 Tadley Hill. Extending the double yellow lines will prevent the parking of vehicles nearer the junction, meaning that there is more capacity for vehicles to wait on The Green, before continuing their journey. The extension will also protect a nearby uncontrolled pedestrian crossing, to enable pedestrians to cross the road in a safer environment.

2. Article 6 of The Principal Order shall have effect as though plans: X117 attached thereto are replaced by plans: X117 attached hereto.
3. The Principal Order shall be revoked to the extent specified in the Schedule to this Order
4. This Order shall come into operation on the *Saturday 22nd August* 2026 and may be cited as “The Hampshire (Basingstoke and Deane) (Prohibition and Restriction of Waiting and Loading and Parking Places) (Consolidation) Order 2026 (Variation No. 4) (The Green, Tadley) Order 2026”.

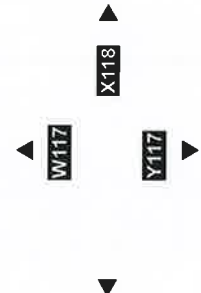
